 - OAEDC- Rob-
 - 120 clients in last year- about 1/3 are expansions
 - 2 major clients for business on Westside (not ready to be public)
 - working with 2 hotel projects
 - new landscape/clean up on the Jeld-Wen site
 - R&D- pharmaceutical company- possibly looking at Oshkosh
 - working with 3 clients for the revolving fund
- Unemployment for July 7.4%
- Oshkosh ranked 4th in state for economic strength
- ranked 51st as small cities

Guest Speaker: Allen Davis- Director Community Development- City of Oshkosh

- Building Inspection
 - building inspection on time target 95%- actual in 2013=98+%
 - commercial plan review target less than 5 days- actual was 3.6 days in 2013
 - are now able to do plan reviews for all size building, not limited by state
 - reducing backlog- about 50% of 300 outstanding projects have been inspected and closed out
 - inspection counter- previously permits issued 35% of the time, staffing changes resulted in 80% to 85% success- goal is 90%
- Planning and Zoning
 - TIF District #25- City Center Hotel Project- city put 2 million upfront into the project
 - TIF District #26-Aviation Business Park-
 - created to help finance sewer/water/infrastructure
 - city/county purchased 80 acres to attract Aviation business
 - UW-O looking to use one of the lots for a business accelerator
 - zoning ordinance update in progress through 2014
 - LEAN process for engineering/storm water review underway- recommendations due this fall
- Assessor
 - contract commercial assessor retained for 2013-2014
 - 200 commercial properties records updated(10% per year) to keep closer to 100% value
- Economic Development
 - revolving loan funds established in 2014-TIF cash balance upon close out \$1,000,000+
 - 2 TIF districts due to be closed out in the next year
 - may keep the money for the revolving loan fund or use 1/2 million to join the Wisconsin Economic Development Fund- allows Oshkosh businesses to access the money in the fund
 - city contribution up to \$25,000 for future economic development marketing
 - opportunity Oshkosh rollout
 - Roadway property cleaned up and added to business park- for future office site
 - EDA grant for Aviation business park for \$2,000,000 pending- expect answer this fall
 - rail spur for loading in SWIP- looking for new location- working with the railroad -needs to be relocated in the industrial park
- Riverwalk Update
 - 2010-2013- finished northside (\$2,000,000 grant)
 - 2012-2013- Steiger Park/Fishing pier (\$500,000 grant)
 - 2013-2014- Boatworks property (\$600,000 grant) will be more expensive due to replacing seawall
 - 2014-2016- Jeld-Wen site (grant applications pending)
 - 2017-2018- Pioneer Drive/Pioneer Island
- Redevelopment Sites
 - Rivers 2- WEDC grant of \$300,000-
 - Marion Rd area- Alliance Development- 80 unit bldg
 - Jeld-Wen - WEDC grant of \$150,000- help with demolition
